



FOREIGN TRAVEL GUIDANCE NOTE

Whether you are travelling abroad for business or pleasure hopefully your journey will be accident free but this guidance note has been produced to assist you in the event of an accident.

If you still have any questions after reading the note please contact your insurance agent or an Arista Insurance office.

What To Do In The Event Of An Accident

If possible a European Accident Statement should be completed. This document is different to the normal claim form you might use in this country and can be obtained from your insurance agent.

It is usual on the continent for the European Accident Statement to be completed by drivers involved in an accident. If you are asked to complete a Statement written in a language you are not familiar with refer to the English language version, if you have one. The questions will be in the same order regardless of which language they have been written in.

The purpose of the European Accident Statement is to help motor insurers settle claims quickly and fairly. It does not constitute an admission of liability on the part of either of the motorists involved.

By providing drivers with the Statement and inviting them to complete it after an accident with another vehicle insurers obtain an account of the details of the accident (agreed by the drivers concerned) immediately after the occurrence, while the events are still fresh in their minds.

The use of the Statement is not compulsory and no offence is involved if it is not completed. Where it can be completed it will help the Equity Claims staff deal quickly with any claims arising out of an accident.

You should only sign the Statement if you are satisfied that the information relating to the circumstances of the accident is complete and correct.

Instructions For The Completion Of The Motor Accident Report Form

This form will be found on the back of the English version of the European Accident Statement and need to be completed as a separate document. Please make sure that all the questions are correctly answered and send immediately to:

Details of accidents occurring in any of the countries listed below should be reported immediately to Equity Claims Ltd as shown above and also to the appropriate local agent in respect of the country shown below in the case of Third Party Death, Bodily Injury or Property Damage.

If your vehicle is damaged and there is no Third Party involved there is no need to contact our local agent if your vehicle is still mobile following an accident.
